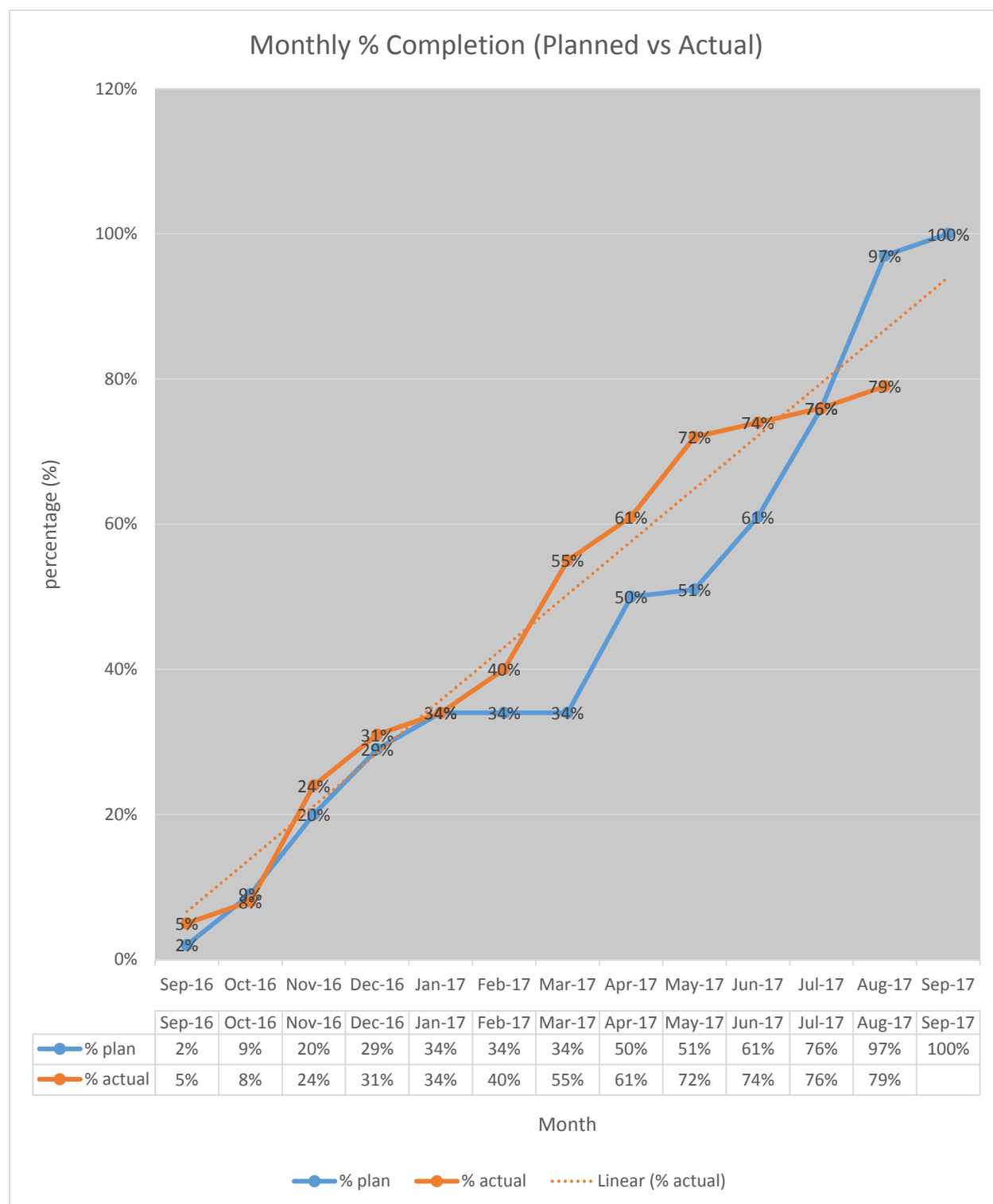

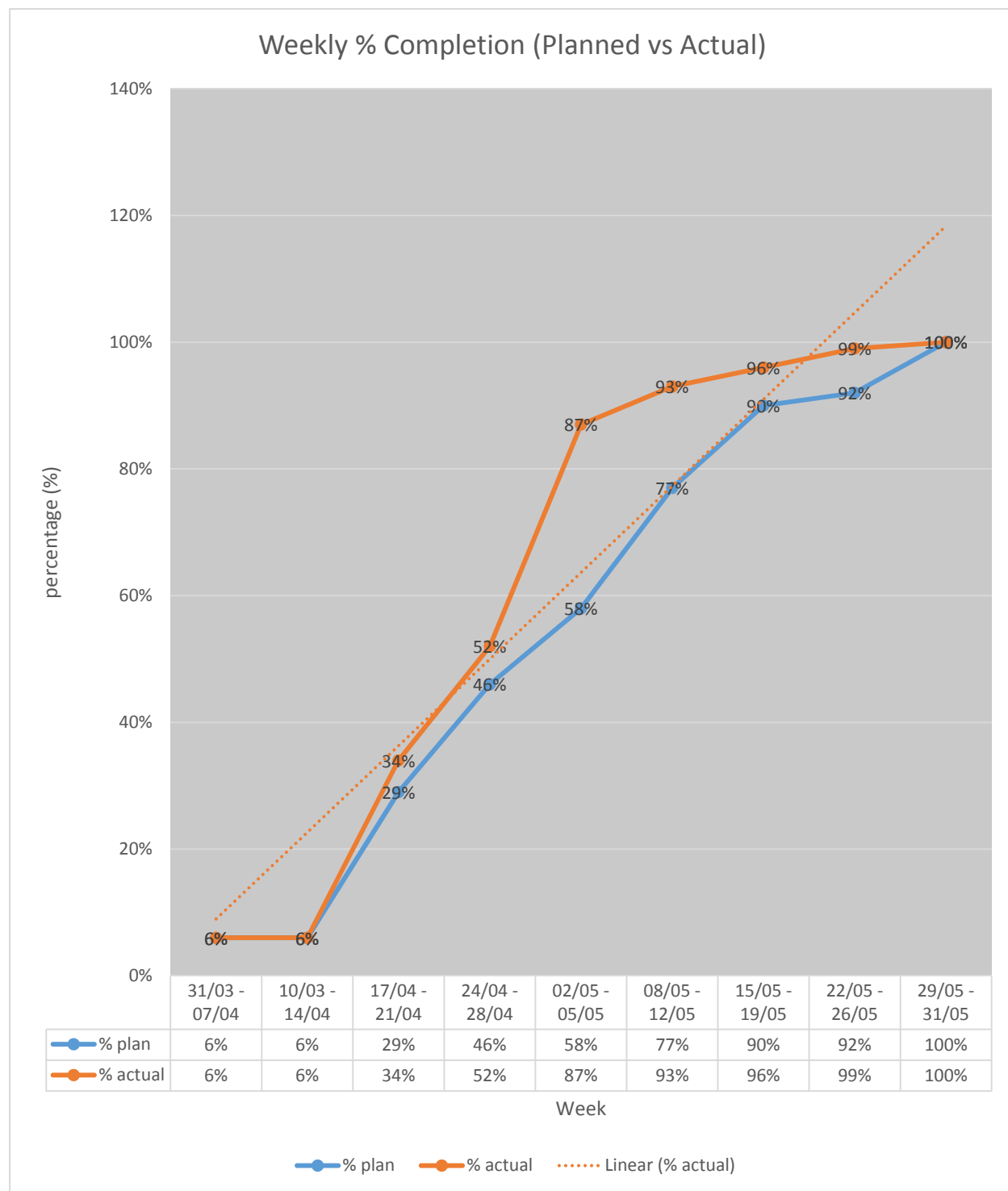

## Overall Monthly Percentage for Overall Timeline



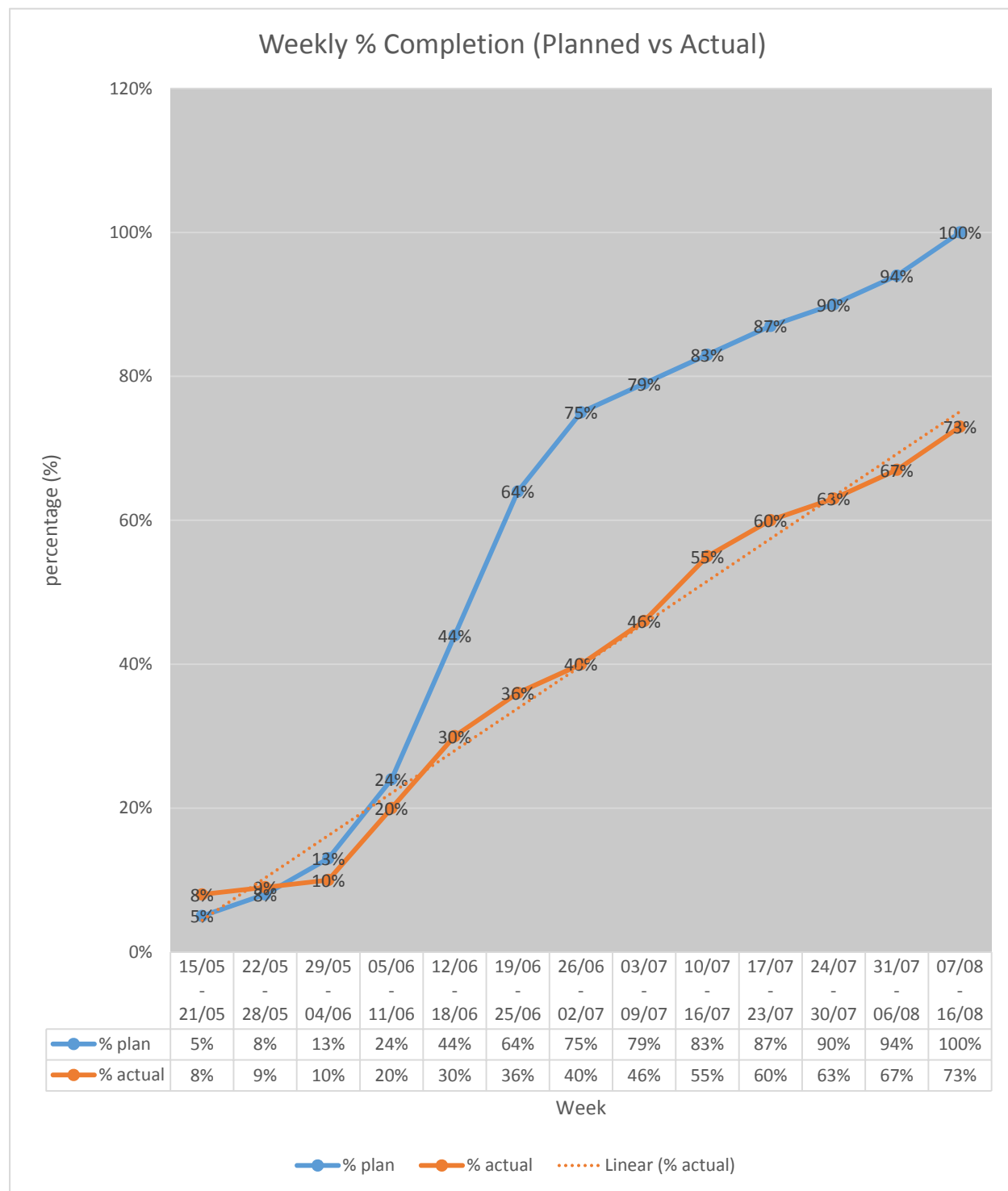
